#### 1. Call to Order

Barone requests new item on agenda: adding a member to the Grievance and Workplace Concerns committee.

Wishnia requests to add an item under new business.

Wrigley motions to adopt agenda.

#### 4. Officer Reports

Quinn verbally reports several meetings with Stony Brook Council, Management and HSC chapter about UUP legislative agenda and how to advocate locally. The general membership breakfast was a success as were "Meet and Greets" and the Fund SUNY Now rally. The Southhampton space is being rehabbed. Quinn has met with Qube (HSC chapter presidents) to begin building a campus Labor Council, so that all unions on campus can work together. He has been in touch with Statewide officers (Fred, Jaime, and Jeri) about member issues, compression/inversion salary increases, LM meetings, and finance. He met with director of alumni affairs. At the next general membership meeting there will be representatives from the student emergency support fund and others to discuss the upcoming 2020 census.

Bello asks about DSI. Quinn says the SBU analysis was complete and approved by Albany. DSI should be in Feb 5 paycheck.

Asare asks when people will be notified. Quinn says we do not know but he will ask management to find out.

Wishnia asks about joint meetings with HSC chapter. Quinn we are planning an officers meetings so the two chapters can get to know each other better and can coordinate better.

Wolfskill reports that Fred Walter reported that a Binghamton officer had a title change so that the compression analysis. Walter explains that at Binghamton local titles were downgraded in order to game the system.

Dubnau reports that the Grievance and Workplace Concerns committee has been very busy. Some general themes include the issue of permanent residence, sabbatical denials, and salary inequity. Faculty need permanent residence to get promoted with tenure. There has been a question whether sabbaticals are being denied on the basis of teaching needs. There is much confusion because of the compression formula, which addresses some inequity but not all inequity issues.

Larson asked about where the Sabbatical denials are occurring and Dubnau responds CAS. Dubnau explains they are going to ask about CAS first and then look across the campus.

Hershowitz reports about MOUs that were made at Courtland/CUNY(?) regarding adjuncts. The MOUs represent some gains for adjunct. Hershowitz is trying to bring a version of that MOU to SBU so that those gains are present here as well. Some contingent coffee hours are being planned to bring contingents out of the shadows. On the political action side, the Political Action group is lobbying lawmakers in February for funding, and is meeting with state senators. This is cross-SUNY we are going with more people. The opening of Ken LaValle's seat is a huge opportunity. Pay attention to that race.

As are asks about the MOU. What's the plan once the MOU is prepared? Hershowitz explains that the next step is to get approval from the chapter and statewide UUP leadership and then to get contingents involved and galvanized before presenting to management. Dubnau asks that tenured faculty and staff show solidarity with the adjuncts.

Solar-Greco highlights from his report that membership drives are working. NEO had 100% enrollment, in large parts due to follow-ups by the dept reps. Please attend upcoming member meetings.

There is a motion to accept offers' reports as presented (written reports are attached).

Quinn reports that Hammond has stepped down. The excutive board can choose to hold another election or appoint someone to complete the term.

Quinn reports that DA elections for statewide office are being held this spring. Our delegates need to attend.

Wishnia explains that Stony Brook Today was a bus trip that was done once a year. Students, staff and faculty would travel to Albany to explain why SUNY is important. We should try to re-institute Stony Brook Today, especially with new president coming in. Quinn says that this has been raised with management.

Walter reports on a plenary meeting he attended. They were asking for TAP GAP to be filled, for more money for the hospital, and for EOP funding. The governor's budget proposal recently came out and it will take weeks to understand it.

Wishnia reports that NYTimes said that most states have increased funding for state universities except Alaska, Hawaii and New York. Walter adds that 30% comes of SUNY funding comes from the state, which is about twice as much as what other states contribute.
