# - Fall Semester Planning

Ed Quinn: There has been a lot said on campus and will keep a close eye on this. There has been talk on statewide level about how the Fall Semester will play out like the Spring Semester. Not sure if the Chancellor will come up with Guidelines. What is said on campus is not necessarily what will come to be.

Joshua Dubnau: Many faculty have concerns with plan A for fall with 250 students in classroom with 100% in person learning. Not all students will be vaccinated. UUP needs to do more and needs to reach out to Faculty and Staff and advocating to Administration.

Tow Wilson: I am the chair of the University Senate Environment Committee and they are working on the issues of the telecommuting from an environmental standpoint. We are sending a survey out to get a report. My Dean sees a growing consensus allowing some remote work will be something long term allowed as long as it can be done effectively.
